The officials concerned may be allowed to exercise their option, if any, under FR-22 (1)(a)(i) within one month from the issuance of the order granting the financial upgradation under the Modified Assured Career Progression Scheme.

However, the grant of higher grade pay is subject to the audit observation, if any, and with the condition that in the event of over payment, which may be detected at a later stage, the same shall be recovered from the pay of the officials and in this regard an undertaking may also be obtained by the concerned H.O.O. from the official, prior to pay fixation. The financial upgradation under Modified Assured Career Progression Scheme shall be purely personal to the employee and shall have no relevance to his seniority position.

The concerned Head of Office is requested to ensure before issuing final pay fixation order that regular service of the officials does not include the period of service rendered in State Government/Statutory Body/Autonomous Body/Public Sector Organizations as the period of past service in these bodies is not to be counted for grant of financial upgradation under Modified Assured Career Progression Scheme. (Point No. 10 of DOPT OM dated 19.05.2009)

The Modified Assured Career Progression Scheme envisages merely placement in the immediate next higher grade pay in the hierarchy of the recommended revised pay bands and shall not amount to actual/functional promotion of the employees concerned.

The officials who are on deputation will get financial upgradation from the dates shown against their names only on notional basis, however, they will get the actual benefits on the basis of such notional pay fixation w.e.f. the date of their repatriation to I&FC Department.

The concerned Head of Office are requested to issue formal orders for grant of 2nd & 3rd financial upgradation in respect of the above mentioned officials working in their office. However, before issuance of formal orders the Head of Office may again confirm that these officials have completed 20/30 years regular service since the date of their appointment in the service and are **clear from Vigilance angle**.
