1. Brief facts of the complaint

The complainant has alleged that some persons had encroached and built their house on the road illegally due to which the road was blocked and the residents of the locality could not walk freely. In the evening, some mischief mongers were gathering there and creating nuisance. He made a complaint to local police in this regard but police did not take any action.
