1. Brief facts of the complaint

The complainant has stated that his father Shri Jai Bhagwan had purchased one bigha Pukta 9 Biswa land from his relative Shri Mahavir on 3.10.1975 and constructed his house and started living there with his family. The complainant has further stated that a 60 feet wall in the North side of his house had come down as a result the house became unsafe and a theft also took place. On 12.12.2013, he called the construction labourers. Shri Pankaj s/o Shri Mahavir presently posted in PS Karawal Nagar Shri Mahibir s/o Shri Shriram Singh and other 3-4 persons came there and abused the labourers. When objected by his wife, Shri Pankaj also used indecent words against his wife and misbehaved with her and also took out a revolver and threatened to kill her. The labourers were run away from the place. When the complainant tried to talk with Shri Pankaj and his friends, he was also beaten up. A complaint was lodged in PS but no legal action was taken by the police. On 17.12.2013 at 8.00 p.m., Shri Pankaj and his four unknown associates forcibly entered in his house, put a pistol on his ear and threatened him not to construct the wall. He also pressurized him to take his complaint back. The

complainant has requested to take legal action against Shri Pankaj and others for violating the law.

2. **Proceedings in the Public Grievances Commission**

The PGC has convened its first hearing on 24.3.2014 and the second hearing on 21-04-2014. At the latest hearing, the following were present:-

1. **Relevant facts emerging during the hearing**

An ATR has been filed by Addl. DCP (N/E) stating that:-

“ the jurisdiction of the complaint in question was in the area of Police Station Loni, Ghaziabad, U.P. and therefore the complaint along with enquiry report of ACP/PG Cell has been sent to the SSP, Ghaziabad for further necessary action”.

4. **Directions of PGC**

Since the matter pertains to SSP, Ghaziabad, and the complaint has already been forwarded by N/E District to the SSP, Ghaziabad, no further action is required. Therefore, the Commission has decided to close the case.
