**1. Brief facts of the complaint**

The complainant has alleged that she was married to Shri Salim Siddiqui, and after marriage she was harassed and tortured by her husband and in laws. She was expelled from her matrimonial house in November 2012 with a young son and since then she has been living with her elder brother in Seemapuri. The complainant has alleged that even after registration of FIR No.497/13, the I.O had not arrested the accused persons on one pretext or the other. The complainant has requested for arrest of her husband and further legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 8-5-2014, when the following were present:-

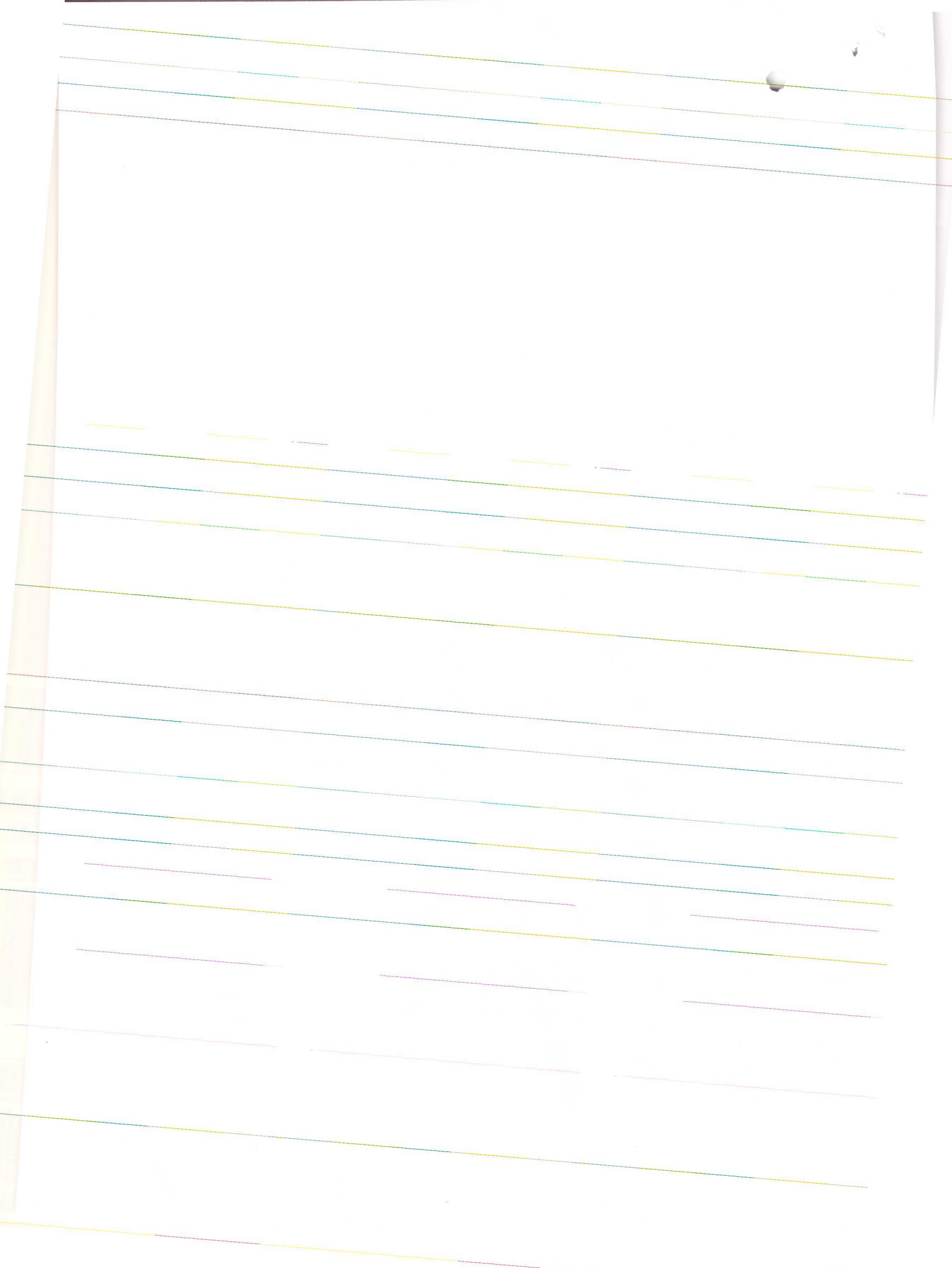

**3 Relevant facts emerging during the hearing**

An ATR has been filed by SI Sandeep Singh/PS/Aman Vihar stating that:-

"During the investigation, statement of complainant and her family members and witnesses were recorded who also supported the



allegations made by the complainant. From the investigation conducted so far sufficient evidence against the husband of the complainant had come on file. After taking permission from ACP/Sultanpuri accused Shri Mohd Saleem (husband) was taken and on 4-4-14 he was arrested. On 19-04-14 Shri Virender Kumar Goyal, ASJ Rohini Courts granted bail in the some of Rs. 25000/- with a surety after settlement between complainant Smt. Parveen Siddiqui and accused Shri Mohd Saleem in Mediation Cell.

Keeping in view the above the complaint of Smt. Parveen Siddiqui may be filed"

Another ATR has been filed by Shri Sanjay Kumar IPS/Addl Commissioner of Police/OD stating that:-

"Enquiry has been conducted by ACP/Sultanpuri which revealed that a case FIR No. 497/13 u/s 498A/406/34 IPC has already been registered at PS Aman Vihar on the complaint of the complainant Smt. Parveen Siddiqui. During investigation, Shri Salim Siddiqui the husband of the complainant was arrested who is running in JC. The allegation levelled by the complainant remained unsubstantiated".

Since the complainant is not present today, copies of the ATRs are being sent to her.

#### 4. Directions of PGC

In view of the ATR filed by the police, no further action is warranted as necessary action has already been taken by the I.O and the matter has already been settled by the complainant and her husband before the Mediation Cell. Therefore, the Commission has decided to close the case.
