It has been observed that death certificates in respect of abovementioned five persons had been received by New Delhi District and these death certificates had, further, been distributed to the next of kin of deceased persons by the District New Delhi but disbursement of compensation in respect of above mentioned five persons could not be made citing reason that " have received compensation of Rs. 5 lakh from Uttarakhand Government" by relatives of above said deceased persons.

In this regard, it is directed to collect the original death certificates issued as above in names of above said deceased persons from the next of kin whom the SDM (New Delhi) had handed over these death certificates so that same may be returned to Uttarakhand Government alongwith Compensation amount. Further, a copy of death certificate issued by Uttarakhand Government to above said deceased person against which compensation amount had been paid by Uttarakhand Government may also be collected from the next of kin for record purposes.

It is requested that a report on above subject may be sent to this branch within 07 days so that the Pr. Secretary-cum- Divisional Commissioner could be appraised on the issue. This matter may be given "**TOP PRIORITY**"
