They shall be required to pass a test in typewriting at at the speed of 30 w.p.m. in English or 25 w.p.m. in Hindi on manual typewriter or at the speed of 35 w.p.m. in English or 30 w.p.m. in Hindi on computer (35 w.p.m. and 30 w.p.m. correspond to 10500 KDPH/9000 KDPH on an average of 5 key depressions for each word) during the period of probation to be conducted by Directorate of Training & Technical Education, Govt. of NCT of Delhi, during the period of Prabation. Their services will be governed by the DASS Rules, 1967, as amended from time to time and any other administrative orders in force.

These officials may exercise their option with regard to fixation of pay, if any, as per FR 22 within one month from the date of promotion or appointment to the post of Grade IV (DASS).

They shall not be granted any increment in the scale of Grade IV(DASS) unless either they qualify the typewriting test at the prescribed speed or they are exempted from passing type test by the Competent Authority.
