5. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
6. This certificate may not be treated in any case for regularization of unauthorized construction, if any.
