2. No trade susceptible to cause ignition by generating heat, mechanical / electric spark should be allowed within the premises and its vicinity.
3. No combustible material and /or other articles shall be permitted to be stored in the safety space around the godown.
4. No cooking or naked light shall be permitted in safety zone.
5. The Chowkidar hut shall not infringe the safety zone.
6. The employee working at the godown must be taught the correct method of operation and maintenance of the extinguishers.
7. Overhead electric cable not passing across the licensed premises.
8. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director DFS Form 'J'(sub rule (1) of rule 37) along with copy of this Certificate, six months prior to its expiry.
9. The owner / occupier shall submit a declaration every year in Form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in).
