The up-gradation is further subject to the following conditions:-

- (A) Pay & Allowance of the incumbents will be fixed under the provisions of FR-22(I) a (1) subject to the terms & conditions contained in DOPT O.M. No. 35034/3/2008-Estt. (D) Dated 19-05-2009 respectively. **The officials concerned may be allowed to exercise their options, if any, under FR-22 (I) a (1) within one month of the Issue of the order, granting the financial up-gradation under the MACP scheme.**
- (B) At the time of fixation of pay of the above employee, the DDO shall again confirm that concerned officials either have completed 10/20/30 years of regular service or they have spent 10 years continuously in the same grade pay for grant of benefit of 1<sup>st</sup>/ 2<sup>nd</sup>/ 3<sup>rd</sup>/ financial up-gradation under MACP Scheme without any break or unqualified service.

- (C) The financial up-gradation is merely placement in the next higher Grade Pay in the cadre and this does not functional in regular promotion or seniority benefit etc.
- (D) The financial up-gradation is subject to verification of Audit.
- (E) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- (F) The DDO concern shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
