

3. The period of service rendered on look after charge will not count as officiation in the higher grade for any purpose.
4. The competent authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
5. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
6. The above is further subject to the outcome of Court case of Sh. A.K.Awasthi & others V/s Govt. of NCT of Delhi & Others pending in the Hon'ble High Court/CAT.
