In compliance of Hon'ble Central Administrative Tribunal's order dated 05/08/2014 in the matter of Shri Vinod Kumar & others V/s DJB and order dated 28/11/2011 in the matter of Shri Inder Pal Singh & others V/s DJB, the case of 52 officials was put up before Departmental Screening Committee, constituted for the grant of 1<sup>st</sup> /2<sup>nd</sup> financial up-gradation under ACP Scheme to eligible officials in accordance with the instructions contained in O.M. The up-gradation is further subject to the following condition:-

Pay and Allowance of the incumbent will be fixed under the provisions of FR - 22 (I) a (1) subject to the terms and conditions contained in Dir(A&P), circular No. DJB/AC(W)/ACP/99/7377 dated: 30.11.1999 and clarification dated: 05.11.2000. The officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade. If any, under FR - 22 (I) a (1) within one month of the issue of the order for granting the financials up-gradation under the ACP Scheme.

ACP Schem

- Before fixation of pay under ACP Scheme, DDO concerned shall ensure/verify that considers employee has completed 12 & 24 years of qualification service as on 09.08.1999 respectively for granting benefit of 1<sup>st</sup>/2<sup>nd</sup> financial up-gradation under ACP without any break or unqualified service.
- The DDO concerned shall also ensure/verify that the employee recommended by DSC has been granted any in-situ or other financial upgradation /promotion .Further explanation will be called for none submission of cases for granting financial upgradation under ACP by the DDO in time.
- The financial up-gradation is merely placement in immediate next higher grade pay and this does not amount to functional regular promotion or seniority benefit etc.
- 5 The financial up gradation is subject to verification by the Audit.
- DJB employee, if any, in the list will be identified by the DDOs and processed separately as per different rules/ orders in such cases.
- The DDO concerned shall Also ensure that none of the employees recommended by the DPC has earlier been granted the same ACP.
