

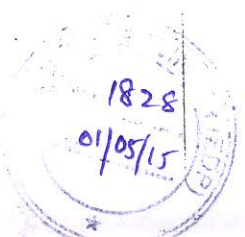

The up-gradation is further subject to the following conditions:-

- 1 Pay and Allowance of the incumbent will be fixed under the provisions of FR-22(I)a(1) subject to the terms and conditions contained in O.M. No. 35034/3/2008- Estt.(D) dated: 19/5/2009 of DOPT for MACP case and Dir.(A&P)'s circular No DJB/AC(W)/ACP/1999/7377 dt. 30.11.1999 and further clarified vide circular No. DJB/AC(W)/2000/29263 dt. 05.11.2000 for ACP respectively. **The official concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade. If any, under FR-22(I)a(1) within one month of the issue of the order for granting the financials up-gradation under the MACP Scheme.**
- 2 Before fixation of pay under MACP scheme, DDO concerned shall ensure/verify that considered employee has completed 10/20/30 years regular service or he has spent 10 year continuously of qualifying service as on 01/09/2008 for granting benefit of 1st/2nd/3rd financial up-gradation under MACP and has completed 12/24 years of qualifying service as on 09.08.1999 under ACP without any break or unqualified service.

3 The DDO concerned shall also ensure/verify that the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion.

4 The financial up-gradation is merely placement in immediate next higher-grade pay and this does not amount to functional regular promotion or seniority benefit etc.

5 The financial up-gradation is subject to the verification by the Audit.

6 The DDOs will verify that the employee recommended for financial up-gradation was not under currency period of penalty, on the date from which financial has been recommended to him.

7 DDA employee, if any, in the list will be identified by the DDOs and processed separately as per different rules/orders in such cases.

(Note:- for Sl.No.3, if any discrepancy found in the fixation of pay, DDO concerned can fix the pay of individual as per rule after approval of accounts concerned.)
