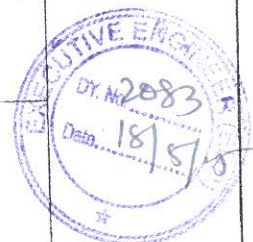


The pay and allowances of the incumbents will be fixed under the provision of FR-22 (i) a (1) subject to the terms and conditions contained in the DOP&T order number 35034/3/2008-Estt (D) dated 19.05.2009, issued under the signature of Dy. Secy. to the Govt. of India and including subject to implementation of penalty orders etc. while implementing the above MACP/ACP scheme by the DDO concerned. The scheme is operative w.e.f 01.09.2008.

Before fixation of pay under MACP/ACP scheme, DDO concerned shall ensure/verify that the above officers have completed 10, 20 and 30 years/12 & 24 years qualifying service, as the case may be, on the above dates (vide column -4), without any break or unqualified service and he/she should be clear from vigilance angle.

The financial up-gradation is merely placement in next higher grade pay and this does not amount to functional/regular promotion or seniority benefits etc. in the grade.

All the conditions/stipulations contained in DOP&T OM dated 19.05.2009 be strictly followed while implementing the MACP/ACP scheme in respect of concerned officials.


