INSTRUCTIONAL ORDER

SUBJECT:- DRAWAL OF FAMILY PENSION BY WIFE/HUSBAND OF DECEASED EMPLOYEES OF DELHI JAL BOARD.

As per CCS Pension Rules 1972 under Rule 54, family pension is payable to the wife/husband of deceased employee. The family pension is applicable till he/she re-marries and the family pension will be dispensed off from the date of re-marriage. An instance has come to the notice of the undersigned that one of the family pensioners has got remarried and also continued to draw family pension on the basis of false declaration in this regard. This is violation of CCS pension rules and as such she had drawn family pension in an illicit and unlawful manner and as such the amount drawn by this family pensioner from the date of remarriage is recoverable and necessary action is being initiated in this connection.


The competent authority has directed the undersigned to request all DDOs to inspect the record of staff working under their control and ensure that no such employee "who has been appointed on compassionate grounds in Delhi Jal Board and is also drawing family pension has been remarried." If family pensioner has remarried and he/she has given this information in your office, the same may be forwarded immediately to the office of the undersigned in the following format:-

The above information may be forwarded to this office within 15 days of issue of this circular. If no report is received within stipulated period, the report will be treated as NIL and in case any such violation of pension rules is noticed/intimated to this office, strict action will be taken against defaulting officials and controlling officers.

It is also requested that an undertaking from all such employees regarding their marital status as on date, may also be obtained and placed in their P.F. & S.B.

This circular may be given wide publicity.


