**ORDER**


This order will dispose off an appeal received on 21.05.2015 filed by Sh.Damanjit Singh, under Section 19(1) of RTI Act-2005.

The matter was taken up for hearing on 25.06.2015. Present Shri C.P. Sachdeva for appellant and Shri Krishan Kumar, APIO/ZRO(C)II & Smt. Parveen Kumari, APIO/ZRO(HQ) for PIO. The reply on the RTI application has been given by the PIO/Jt. Director (Rev)HQ on 23.4.2015 within the stipulated time period. However, in the appeal, the aggrieved appellant has mentioned that no action has been taken till today. The APIO/ZRO(C)-II, who was also present during hearing, could not provide any satisfactory proof for taking any action on the previous correspondence made by the appellant on his grievance. The appeal is disposed off with the directions to the APIO/ZRO(C)-II to resolve the grievance within a period of 15 days of issue of this order after going through all necessary documents and following the DJB rules and regulations.

In the light of above the appeal is accordingly disposed off.
