The Competent Authority has approved de-linking of tuition fee from the Scholarship Scheme of Delhi Jal Board and following revision in the rates and eligibility criteria in respect of Scholarship applicable to the employees of Delhi Jal Board with immediate effect:-

**A. Eligibility**

- i. Only group of C and D employees with three years regular services and Muster Roll workers who have completed 240 days are covered under the scheme for payment of Scholarships to their children, studying from VI Class onward and who secured following minimum percentage of marks in the preceding year:-

- ii. In case the number of eligible applicants is found on higher side in a year wherein all these eligible employees are unable to cover within the provided budget, in such a situation all those eligible employees may be granted scholarship at the minimum laid down rates.

- iii. The employees whose children are getting reimbursement to Tuition Fees from Department are also entitled to get Scholarship. Only two children as per guidelines as laid down by G.O.I. in respect of reimbursement of Tuition Fees are entitled for Scholarship.
