The Pay and allowances of the incumbents will be fixed under the provision of FR-22 (I) a (1) subject to the terns and conditions in the DOP&T order No. 35034/3/2008-Estt(D) dated 19/05/2009. issued under the signature of the Dy. Secy. to the Govt. of India and including subject to implementation of Penalty orders etc while implementing the above MACP/ACP scheme by the DDO concerned. The scheme is operative w.e.f. 01.09.2008.

The officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade if any, under FR-22 (I) a (1) within one month of the issues of the order, granting the financial upgradation under the MACP/ACP Scheme.
