MEMORANDUM


The undersigned is directed to state that the Government of India has taken note of the current constitutional position in Delhi and major instances of violation of the Constitution, laws and rules, such as change in the pay structure of DANICS officers, the constitution of the so-called Commission of Inquiry, etc. Government of India has declared these decisions/orders of the GNCT of Delhi, viz. change in pay structure of DANICS officers, constitution of Commission of Inquiry to inquire into the allegations regarding the award of work related to CNG Fitness Certificate, as illegal and *ab initio* void.

2. Government of India has *inter alia* conveyed to all the Administrative officers of the All India Services, DANICS, HODs, DDOs and other concerned officers placed with Government of NCT of Delhi that "the orders declared illegal by the Government of India should not be complied with. Should any officer choose to do so, both disciplinary action for compliance of illegal orders, and recovery of financial loss caused to the Government as a result of such action, would follow".

3. In view of the above directions of the Government of India, it is hereby reiterated to all Principal Secretaries / Secretaries, Head of Departments, officers of All India Services, officers of DANICS, DDOs and other concerned officers placed with the Govt. of NCT of Delhi, that the aforesaid orders, declared illegal by the Government of India, shall not be complied with. If any action has been taken in this regard, it should be immediately rescinded. Further, any officer who disregards the above directives of the Government of India shall do so at his own risk, and will be liable for appropriate action by the competent authority, including disciplinary proceedings and recovery of financial loss incurred, as a result of such action.

4. Further, the undersigned is directed to convey that any officer placed with the Government of NCT of Delhi who acts contrary to the directions/orders of the Government of India or its delegatee, i.e. Lt. Governor, Delhi, and takes any action against the provisions of the Constitution, laws and rules to implement illegal and *ab initio* void orders, will be held responsible for such action and shall invite action mentioned in para 3 above.

5. This issues with the approval of the Hon'ble Lt. Governor, Delhi.
