The Office Memorandum no. S. 11011/2/2008-CGHS (P) dated 20.05.2009 issued by Ministry of Health & Family Welfare, Department of Health & Family Welfare, Government of India, Nirman Bhawan, New Delhi, regarding revision of rates of subscription under Central Government Health Scheme due to revision of pay and allowances of Central Government employees and revision of Pension / Family Pension on account of implementation of recommendations of the Sixth Central Pay Commission was circulated vide this office endorsement no. DJB/DD(LW)/ Medical/ 2013/16631 dated 11.02.2013. In the said order it has clearly been mentioned that Pensioners have an option to get their Medical Pensioner Card made either by making Medical Contribution on Annual Basis (Twelve Months) or by making contribution for 10 (Ten) years { 120 (One Hundred Twenty) months} for getting a Pensioner Medical Card with Life-Time validity.

Reference are being received in DJB regarding depositing of contribution by the spouse after the death of a pensioner enrolled himself /herself as a life member of the Delhi Jal Board Employee Health Scheme and also issuance of Medical Card of the pensioner on the day of retirement.

Both the matters have been examined as per policy of CGHS and DGHS and it has been decided that henceforth:-

1. Officers/officials of DJB may apply for issue of Medical Card three months before the date of retirement on superannuation but the Pensioner Medical Card will be issued to him/her on the next working date or retirement by the DDO and they will be allowed medical facility **from last office not from any other office**. Cash subscription should be deducted from his Pension/Commutation/Gratuity / Leave Encashment or last salary. Intimation in this regard must be sent to Pension Disbursement Cell while sending file for release of Pension; and
2. In case, a pensioner has deposited lifelong subscription under the Delhi Jal Board's Medical Scheme, his/her spouses/dependents shall not be charged again on account of issue of New Pensioner Medical Card after the death of pensioner.

This issues with the approval of Competent Authority.
