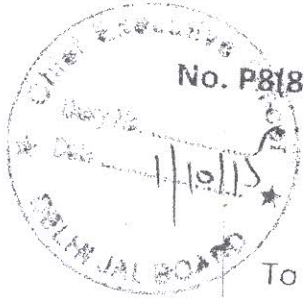

OFFICE MEMORANDUM

To strengthen primary healthcare service, Government has decided to set up 1000 Aam Adami Mohalla Clinics with a total built up area of about 50-60 sqm. One Aam Adami Mohalla Clinic will serve about 10,000 to 15,000 population, for providing access (within one km) to public.

About 575 locations for Aam Adami Mohalla Clinic, have been provisionally identified (list enclosed); and more need to be identified to make a total of 1000.

In order to identify and finalize the sites suitable for setting up Aam Adami Mohalla Clinics, districtwise committee's consisting of following officers are constituted:-

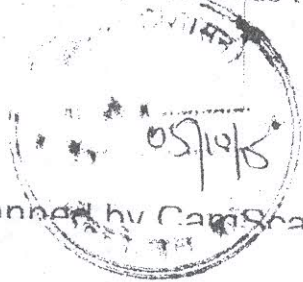


