6. The above is further subject to the outcome of Court case pending before the Hon'ble High Court/CAT, if any.

The aforesaid officials are hereby directed to report to Director(A&P) for further posting as AE(E&M). However, Shri Harminder Singh Bhist at sr.No.5 above, will continue to work in the office of EE(E&M)W&S South-III due to his retirement on 31.12.2015.
