In pursuance to the decision of Delhi Jal Board dt. 27.05.1998 regarding opening of Additional Control Room at the residence of its nominated Members and providing the facility of Telephone with Attendant, Sh. Sagar Verma S/o. Sh. Jai Gopal Verma R/o. 124 Ram Nagar, Krishna Nagar Delhi-110051, is hereby engaged as a 'Telephone Attendant' on contractual basis at the residence of Sh. Jai Gopal Hon'ble Member (DJB) w.e.f. 01.09.2015 initially for a period of 06 months (180 days) up to the period 27.02.2016 with ex-post facto sanction at the first instance @ consolidated remunerations as fixed by Govt. of NCT of Delhi under the minimum wages Act under un-skilled category from time to time at the first instance or till further orders whichever is earlier. His services will be co-terminus with the tenure of Sh Jai Gopal, Hon'ble Member of Delhi Jal Board at whose residence he is being posted to work.

The expenditure of the wages of above mentioned worker shall be charged to the contingency head of Head Quarters and his attendance record will be maintained by A.C.(GAB). His engagement is further subject to the following terms and conditions: -

1. That as casual/ daily wages/ temporary workers, he will have no lien on the job for which he is being engaged. Neither he will have any right to be engaged against a permanent vacancy nor he will have any claim for regularization to the post.
2. That in case of continuous absence for 08 (Eight) or more days without prior approval/permission, his services shall stand automatically terminated without any information and some other person, if necessary, shall be engaged in the interest of work through Administration.
3. That he will not be entitled to any other benefits, privileges which are available to the regular employees.
4. That his services shall be liable to be terminated at any time without any notice or without assigning any reason thereof.

Apart from above, further extension has been granted w.e.f. 24.6.2015 upto 31.8.2015 in respect of Shri Deepak Sehgal who was previously working as Telephone Attendant at the residence of Sh. Jai Gopal, Hon'ble Member of Delhi Jal Board upto the period 31.8.2015 and after that he has left the job.
