ORDER

This order shall dispose off the present appeal filed by Ms. Vijaya Kumari Srivastava, R/o H. No. 7, Bhoop Singh (E) Colony, Rajpur Khurd, New Delhi on 01/10/2014 under the provision of Right to Information Act, 2005, against PIO/SDM (Saket).

The said appeal was filed by Ms. Vijaya Kumari Srivastava in respect of RTI ID No. Nil/SDM (Saket) against the PIO/SDM (Saket). In this matter, Notice was issued from the office of the First Appellate Authority on 20/10/2014 for hearing in this matter on 13/11/2014 at 12.00 Noon. On 13/11/2014, Ms. Vijaya Kumari Srivastava was not present and none appeared on behalf of PIO/SDM (Saket) despite service of notice.

I have gone through the RTI application. On perusal of record it has been found that the appellant has not received reply against her RTI. The PIO/SDM (Saket) is hereby directed to provide correct and complete information, as available on record, to the appellant within 10 days of receipt of this order. Appeal disposed off accordingly.

The RTI application was filed by the applicant to the PIO/SDM (Saket) on 29-08-2014 but till now no information has been provided to her. As per the provisions of the RTI Act 2005, the information is to be provided within 30 days of receipt of the RTI. The PIO/SDM (Saket) to ensure that information is provided in a time bound manner.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikajikama Place, New Delhi-110066, if she is not satisfied with the Orders of First Appellate Authority.
