ORDER

This order shall dispose off the present appeal filed by Secretary, Ansal Villas Residents Association on 24/10/2014 under the provision of Right to Information Act, 2005, against SPIO/SDM (HQ).

The said appeal was filed by Secretary, Ansal Villas Residents Association in respect of RTI ID No. 3714/SDM (HQ) against the SPIO/SDM (HQ). In this matter, Notice was issued to the Secretary of the Association from the office of the First Appellate Authority on 07-11-2014 for hearing on 25/11/2014 at 12.00 Noon. On 25/11/2014, Secretary was not present and none appeared on behalf of PIO/SDM (HQ). Instead some members of the Association present. On 27-11-2014, an Interim Order was passed with the direction to Secretary, Ansal Villas Association to appear in person or send his authorized representative to attend the hearing fixed on 02-12-2014. On 02-12-2014, Sh. Shyam Gambhir, R/o F-16, Ansal Villas, Satbari appeared on behalf of the Sh. Rajan Mayor, Secretary, Ansal Villas Residents Association and Sh. Ashok Kumar, Tehsildar (Saket) appeared on behalf of the department.

I have gone through the RTI application. On perusal of the record, it has been found that the appellant has already received the reply but he is not satisfied with the reply. The PIO/SDM (HQ) is hereby directed to provide correct and complete information, as available on record, to the appellant within 15 days of receipt of this order. The appellant has agreed to deposit the relevant fee. The PIO/SDM (HQ) is directed to inform the appellant about the fees to be deposited within 5 days of receipt of this order.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikamaji Place, New Delhi-110066, if he is not satisfied with the Order of First Appellate Authority.
