ORDER

This order shall dispose off the present appeal filed by Dr. Gian Singh, R/o C-585, Sangam Vihar, New Delhi-110080 on 01/09/2014 under the provision of Right to Information Act, 2005, against SPIO/SDM (Hauz Khas).

The said appeal was filed by Dr. Gian Singh in respect of RTI ID No. Nil/SDM (Hauz Khas) against the SPIO/SDM (Hauz Khas). In this matter, Notice was issued from the office of the First Appellate Authority on 10/10/2014 for hearing in this matter on 14/10/2014 at 12.00 Noon. On 14/10/2014, Dr. Gian Singh was not present and Sh. Ashok Kumar, Tehsildar (Hauz Khas) appeared on behalf of SPIO/SDM (Hauz Khas).

I have gone through the RTI application. Sh. Ashok Kumar, Tehsildar (Hauz Khas) informed that the matter pertains to SPIO/SDM (Saket). In this case if the matter pertains to the SDM (Saket), the concern APIO/PIO had to transfer the RTI within 5 days of receipt of the application. The PIO failed to do so. Accordingly, SPIO/SDM (Hauz Khas) to ensure that if the RTI application does not pertain to his office, it may be forwarded to the concerned PIO in a time bound manner. Further, a copy of the RTI application be sent to the SPIO/SDM (Saket) with this order. The SPIO/SDM (Saket) is directed to provide the complete information as available on record to the appellant within 10 days of receipt of this order. Appeal disposed off accordingly.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikajikama Place, new Delhi-110066, if he is not satisfied with the Orders of first Appellate Authority.
