ORDER

The said appeal was filed by Sh. Raghubir Singh in respect of RTI ID No. 3448/ BDO (South) against the SPIO/ BDO (South). In this matter, Notice was issued from the office of the First Appellate Authority on 10/10/2014 for hearing in this matter on 14/10/2014 at 12.00 Noon. On 14/10/2014, Sh. Raghubir Singh present in person and Yashpal, Panchayat Secretary appeared on behalf of PIO/ BDO (South).

I have gone through the RTI application. The applicant seeks information regarding record of Khasra No. 569 & 570 in which allotment was done by Sh. Nathu and Sh. Jeet Ram, detail of Gaon Sabha Ponds and Wells, detail of allotment of land to the IGNOU, detail of allotment/notification of Khasra No. 569 & 570 of village Maidan Garhi into ridge, details of resolutions passed by the Gram Panchayat of village Maidan Garhi from 1/6/1960 to 31/12/1963, 1/1/1973 to 31/12/1973 and from 1/1/1983 to 31/12/1987 and other information sought by the appellant in his application. The SPIO/BDO (South) is directed to allow inspection of available records within 10 days of receipt of this order on a mutually convenient date. It is further directed to provide up to 10 pages of photocopy of the records free of cost and rest after payment of due fees by the appellant. Appeal disposed off accordingly.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikajikama Place, new Delhi-110066, if he is not satisfied with the Orders of first Appellate Authority.
