ORDER

This order shall dispose off the present appeal filed by Sh. Ajay, R/o S-85/40, Lal Gummad Camp, Panchsheel Park, New Delhi-110017 on 02/09/2014 under the provision of Right to Information Act, 2005, against SPIO/SDM (HK).

The said appeal was filed by Sh. Ajay in respect of RTI ID No. 3603/SDM (HK) against the SPIO/SDM (HK). In this matter, Notice was issued from the office of the First Appellate Authority on 13/10/2014 for hearing in this matter on 28/10/2014 at 12.00 Noon. On 28/10/2014, Sh. Ajay along with Ms. Sushma was present in person and Sh. Ashok Kumar, Tehsildar appeared on behalf of PIO/SDM (HK).

I have gone through the RTI application. Sh. Ajay and Ms. Sushma informed that they have not received the reply of the RTI filed on 10-07-2014 which is a clear violation of provision of RTI Act. The SPIO/SDM (HK) is hereby directed to provide the complete information, as available on record, to the appellant within 10 days from today i.e. 28-10-2014. Further, it is also directed that certificate as requested by the appellant be issued to the him if he is eligible for the same. Appeal disposed off accordingly.

Sh. Ashok Kumar, Tehsildar (HK) came in the hearing without any status report despite Notice send to him. Sh. Ashok Kumar, Tehsildar (HK)/SPIO to ensure that he comes with complete information along with all relevant papers in RTI Appeal hearings.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikajikama Place, new Delhi-110066, if he is not satisfied with the Orders of first Appellate Authority.
