ORDER

This order shall dispose off the present appeal filed by Ms. Rakhee Marwah, R/o D-9, Akash Bharti Apartments, 24, I.P. Extension, Delhi-110092 on 01/09/2014 under the provision of Right to Information Act, 2005, against SPIO/SDM (**Mehrauli**).

The said appeal was filed by Ms. Rakhee Marwah in respect of RTI ID No. 3661/ SDM (**Mehrauli**) against the SPIO/ SDM (**Mehrauli**). In this matter, Notice was issued from the office of the First Appellate Authority on 16-09-2014 for hearing in this matter on 25/09/2014 at 12.00 Noon. On 25/09/2014, hearing was conducted and Ms. Rakhee Marwah present in person and Sh. Ajit, Tehsildar (**Saket**) appeared on behalf of PIO/SDM (**Saket**). On 25-09-2014, an Interim Order was passed with the direction to SDM (**Mehrauli**) to provide the information to the appellant and next date of hearing was fixed on 14-10-2014. On 14-10-2014, Ms. Rakhee Marwah present in person and Sh. Ashok Kumar, Tehsildar (**Mehrauli**) appeared on behalf of PIO/SDM (**Mehrauli**). On 15-10-2014, again an Interim Order was passed with the direction to SDM (**Mehrauli**) to provide the information to the appellant and next date of hearing was fixed on 27-10-2014. On 27-10-2014, Ms. Rakhee Marwah present in person and none appeared on behalf of the department.

I have spoken to the SDM (Mehrauli) over telephone regarding the action taken on the Interim Order passed on 15-10-104 and have already provided the copy of the both the Interim Orders to the PIO for compliance but so far no action taken report has been received from the PIO. The PIO/SDM (**Mehrauli**) is again directed to provide the correct and complete information to the appellant as available on record within 10 days of receipt of this order. Appeal disposed off accordingly.

It was pointed out by Ms. Rakhee Marwah that in the Interim Order dated 30-09-2014 the second line of fourth para, 'cannot' was misprinted as 'cann'. Please read the word as 'cannot' instead of 'cann'.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikajikama Place, new Delhi-110066, if he is not satisfied with the Orders of first Appellate Authority.
