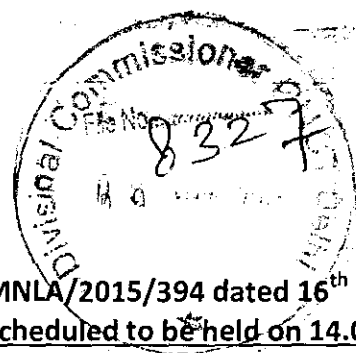

Sir,

In reference to the aforementioned subject and apropos our discussion with your goodself and ADMs/SDMs in your office on Wednesday i.e. March 4, 2015, the National Lok Adalat may be organized in the 11 Districts concerning revenue matters particularly mutation, private nuisance matter u/s 133 of Cr.P.C, recovery matters etc. in the discretion of your SDMs/ADM.

We are supplying two permanent standee to each of the Districts which may be placed at conspicuous places at the offices in the Districts to make public aware about organizing such Lok Adalats on every Second Saturday of the month.

We may request you that the process to issue notice to the parties may be initiated at the end of the concerned SDMs in the Districts. The SDMs/ ADMs who preside over Lok Adalat shall be paid Rs.2,500/- while co-member i.e Government Lawyer or otherwise one who has knowledge of revenue matters shall be paid Rs.1,500/- as honorarium. The payment of honorarium shall also be made to the Ministerial Staff who shall work with the concerned officers. The Presiding Officers shall also be at liberty to arrange for lunch @ Rs.250/- per head for not more than eight persons in total. All the expenses shall be borne by the DSLSA and reimbursed through RTGS.

Looking forward for a success in organizing National Lok Adalat for revenue matters at your end.
