SANCTION ORDER

In supersession and partial modification of previous sanction order of even number dated 27/03/2014, Administrative Approval/Expenditure Sanction of Competent Authority i.e. Secretary (Revenue) – Cum Divisional Commissioner, Delhi is hereby conveyed for drawl of an advance amounting Rs. 36, 10,772/- (Thirty Six Lakhs Ten Thousand Seven Hundred Seventy-two Rupees only) out of total sanctioned amount of Rs.90,26,930/- (including 3% department charges) to DTTDC for making payment towards installation of compactors for Central Record Room at Tis Hazari, Delhi vide sanction order of even number dated 17/7/14.
