<u>INVITATION FOR EXPRESSION OF INTEREST (EOI)</u>

1. INTRODUCTION

Government of NCT of Delhi has established 11 District Urban Development Agencies (DUDA) for each of the eleven revenue districts for implementation of MLA Local Area Development (MLALAD) schemes as well as Mohalla Sabha schemes or Citizens Local Area Development (C-LAD) schemes. Each of the 70 MLAs in Delhi get a fund of Rs. 4 crores per annum under the MLALAD scheme which is to be spent on various development projects in their respective constituencies. Similarly, an amount of Rs. 20 crore is likely to be sanctioned by the Government of Delhi for implementation of development schemes and other works identified by Mohalla Sabhas in each of the Assembly Constituency. In the current financial year, only one Assembly Constituency has been sanctioned Rs. 20 Crore in each of the 11 districts.

During the recent meetings of Mohalla Sabhas, a request has been received from most of the Mohalla Sabhas for installation of CCTV cameras in their respective areas. There are roughly 40 Mohalla Sabhas in each Assembly Constituency; each having a budget of Rs. 50 lakhs for various works identified by them. Also, many of our Hon'ble MLAs have identified installation of CCTV cameras in their respective constituencies as a major work to be undertaken under MLALAD scheme.

2. OVERVIEW OF THE PROJECT

DUDAs intend to install CCTV Surveillance system under MLALAD scheme and C-LAD scheme for live monitoring of activities and their recording 24*7 at various locations to check the activities of mischievous elements as well as for overall security at Mohalla Sabha level and Assembly Constituency level. Typical sites for CCTV surveillance would include gated colonies (like group housing colonies), open colonies, narrow byelanescrowded markets, parking areas and other residential areas/commercial areas.

Suitable surveillance system components (Camera, NVR/DVR etc.) shall be identified by a Committee constituted by Govt. of NCT of Delhi, based on Proof Of Concept (POC)/Technical Specifications and their suitability as demonstrated by short-listed vendors. Subsequently, RFP shall be floated with specification/model number of identified components.
