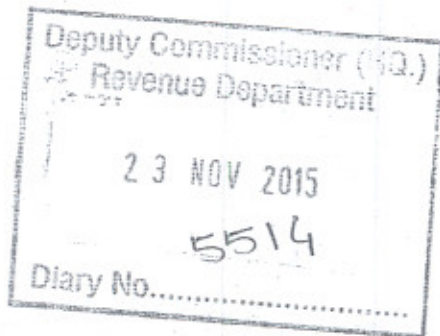

The Commission has been entrusted with the task of making recruitments of various Group 'B' Non-Gazetted and Group 'C' Non-Technical posts in various Ministries/Departments of GOI. The Commission works through its 9 Regional/Sub-Regional Offices which are responsible for conduct of examinations in coordination with the State Administration.

2. As per procedure hitherto followed, the confidential materials (Question Paper bags, etc.) are sent to respect District Collectors/Magistrates of various cities who are designated as Question Paper Receivers (QPRs). The materials are kept in the State Treasury & distributed to the examination venues under the strict supervision of the District Administration. The Commission, has fortunately been receiving requisite cooperation from the designated QPRs.

3. In the last examination conducted by the SSC, Constable GD Examination 2015, a large number of

candidates were caught while they were indulging in malpractice at various examination centres. Various paper chits containing answers of different sets of Question Booklets had also been detected. Similar malpractices were also detected during the conduct of Combined Higher Secondary Level Examination, 2014 held on 02.11.2014, 09.11.2014 and 16.11.2014. While studying the cases, prima facie, it came to light that this leakage is partly due to Confidential materials reaching the venues quite some time in advance before the starting of the examination at 10 a.m. (morning shift) and 2 p.m. (afternoon shift).

4. Under the circumstances, may I request you to issue instructions to the District Administration to keep strict vigilance on the distribution of Confidential material and to ensure that under no circumstances these Confidential materials should reach examination venues before 9.00 a.m in case of morning shift and 1.00 p.m. in case of evening shift.
