The benefits will be admissible with effect from the actual date of his joining to the post of Laboratory Assistant. He will avail the benefits of promotion on joining duty as Laboratory Assistant in this Directorate.

The Head of the Department concerned must ensure that the above promoted employee is actually working in the Group-D post, and no vigilance/ disciplinary case/PE is pending/contemplated against him and he has not been promoted to any other Group-C Post and also possess the requisite qualifications as per Recruitment Rules, SC/ST & PH Certificate (where applicable).

It is also brought to the notice that no request for repatriation to his parent department to his parent post i.e. Group-D, will be accepted in any circumstances in this Directorate.
