Sub: Uploading the requisite data in r/o total number of seats/vacant seats in all classes by the Private Unaided Recognized Schools.

Directorate of Education is committed to ensure the admissions of Economically Weaker Sections and Disadvantaged Group Category in Private Unaided Recognized Schools of Delhi as mandated under the provisions of Right to Education Act, 2009.

The admission process for Entry Level Classes for the academic session 2015-16 has been commenced in Private Unaided Schools of Delhi. The provisions of Right to Education Act, 2009 mandates all the Private Unaided Recognized Schools of Delhi to admit to the extent of at least 25% of the strength of that class (Entry Level Classes i.e. Pre-School, Pre-Primary and Class-I) to the children belonging to Economically Weaker Section and Disadvantaged Group Category and provide free and compulsory elementary education till its completion.

Further, those Private Unaided Recognized Schools (Non-Minority), which are situated on the land allotted by the Government Agencies at concessional rates, are also bound to grant 20% admission to the children belonging to Economically Weaker Sections of the society under Free ship Quota in all fresh admissions in all upper classes other than entry level classes. (Notification No.F.15 (172)/DE/Act-I/2010/20109-20123 dated 30-12-2013)

In order to ensure that the above provisions for EWS/Free ship Seats are strictly adhered to, this Directorate has developed an Online Module to seek the requisite information from the Private Unaided Recognized Schools of Delhi to know the exact number of vacant seats /filled seats in different categories in r/o all the classes so that the same may be put in public domain also.

In view of the above, Heads of the Schools/Managers of Private Unaided Recognized Schools in Delhi are hereby directed to upload the requisite information on Departmental Website www.edudel.nic.in School Plant -> Entry Form -> Updated Status of Enrollment of Open, EWS/DG, Free Ship Quota Seats.

All the private schools shall fill/upload the desired information after the first round of admission and thereafter update it whenever any changes are made.

General public may view the details of total number of seats/vacant seats in the Private Unaided Recognized Schools on this Directorate's website under the head – <u>Updated status of enrolment of Open/EWS/DG</u>, Free Ship Quota Seats in the scroll list.

Further, all the Dy. Directors of Education of this directorate are hereby directed to ensure that all the Private Unaided Recognized schools falling under their jurisdiction must fill the requisite data correctly on the module available on departmental website and submit a certificate to this effect to Act-I Branch for appraisal of the Competent Authority.

Non compliance of the order shall be viewed seriously.
