As the existing contracts/agreement for providing security services in schools/stadia/offices of Directorate of Education GNCT of Delhi are expiring on 14<sup>th</sup> August, 2015, this department has decided to extend the existing contract for providing the security services in schools/stadia/offices of Directorate of Education, GNCT of Delhi under clause 8.6 of the existing tender upto 30<sup>th</sup> September 2015 or award of work to new agencies whichever is earlier.

As such, all the empanelled agencies/firms are hereby directed to provide the security services in Govt. schools/stadia/offices of Directorate of Education, GNCT of Delhi in the same existing terms and conditions for a period of 1½ months only or till the award of work, whichever is earlier.

All the firms will submit a certificate/consent that they shall followed religiously with all the terms & conditions of the existing render within five days of issue of this letter and to furnish a performance security within 15 days of issue of this letter for an amount equivalent of 10% of the total value of the contract in the form of Account Payee DD/FDR/ Bank Guarantee from a commercial bank in favour of Director, Directorate of Education, GNCT of Delhi positively. The performance security shall remain valid for a period of sixty days beyond the date of completion of

all contractual obligations. Non-submission of certificate/ consent and performance security within the prescribed time limit, it will be presumed that the firm/firms is/are not interested for providing the services further and the schools where security guards provided by those firm/firms, will be allotted to other empanelled firm/agency.

Any Laxity/negligence/violation of terms & conditions will be viewed seriously and strict penal action will be taken in case of default.
