ORDER

**Sub:-Registration of buses with the Delhi Transport Corporation
by Private Unaided Recognized Schools of Delhi**

In continuation of this office order of even no dated 18/12/2015 (Copy enclosed) and as per the decision taken in the meeting held on 21/12/2015 under the Chairpersonship of Hon'ble Minister of Transport, following directions are given to all concerned for strict compliance.

The Managers/Heads/Authorized Representatives of all the Private Unaided Recognized Schools are directed to visit their respective DDE's office on 22/12/2015 along with the copies of Contract Carriage Permit (CCP), Registration Certificate (RC), Insurance and Fitness certificates of their school buses.

In this regard, One Nodal Officer from DTC (as per the list enclosed) shall be working in each of the districts so as to carry out the process of registration of school buses on the basis of documents provided by the respective schools for the purpose of hiring the school buses during 1st January to 15th January, 2016 for implementing Odd and Even Concept of vehicles.

Here, it may be noted that for registration, the prime requirement is of an application along with CCP & RC. The schools which do not have Insurance/Fitness certificate of any particular bus must get the needful done and submit the same before 1st January, 2016.

The Managers/Heads/Authorized Representatives of all the Private Unaided Recognized Schools must ensure that all the buses deployed in their respective Schools get registered over the next two days. They shall also ensure that the Drivers and Helpers concerned shall continue to work for running the respective buses during 1st January to 15th January, 2016.

All DDEs shall keep the details/contact number of the Representative/Nodal Officer of the school for any further reference in the matter. Further, they are directed to co-ordinate with the respective Nodal Officer of DTC and personally monitor the said exercise of registration so that it is carried out smoothly till completion.

Non-compliance of the order shall be viewed seriously.


The Government of NCT of Delhi, under the active guidance and direction of Hon'ble Supreme Court, Hon'ble High Court and Hon'ble NGT is working on multi-pronged strategy to combat air pollution in the National Capital which has reached deadly level. One of the few strategies proposed to be implemented by this Government is 'Odd Even Scheme' for non-transport vehicles in Delhi from 1.1.2016 to 15.1.2016.

The Government of NCT of Delhi has the interest of children not only of this generation but also of the generations to come in Delhi and combating air pollution is the need of the hour. To make this new Scheme functional with least disturbance to our children and also to augment public transport during the 'Odd Even Scheme' days, the Government has decided to declare holidays for all schools from 1.1.2016 to 15.1.2016 and also to procure the services of school buses for the requirement of DTC at notified rates. This order may result in some deviation to the number of school days prescribed in the Right to Education Act, but it is the considered opinion of this Government that we need to be flexible about the number of working days notified/prescribed under the RTE Act in the interest of health and well being of our children for all times to come.

Accordingly managements of all Un-aided Recognized Private Schools/Government Aided Schools are directed to declare holidays in the school during the period 01.01.2016 to 15.01.2016.

It is further, ordered that all the un-aided recognised private schools shall provide their fleet of buses to be kept at the disposal of Delhi Transport Corporation at notified rates for which DTC has separately notified Nodal officers at Depot as well as Zonal levels. Respective Deputy Directors of Education should act as Nodal officers to co-ordinate procurement of transport buses from unaided recognized schools falling within their jurisdiction for the aforesaid period.

The Principals/Managements of unaided private recognized schools are instructed to join hands in this endeavour.
