**Sub:- Uploading the criteria and points thereof adopted by Private Unaided Recognized Schools for admissions at Entry Level Classes:-Session 2016-17.**

Directorate of Education vide its circular dated 08/12/2015 at point no. 6 directed all the Private Unaided Recognized Schools of Delhi to upload by 20/12/2015 their criteria and points for admissions of Open Seats at Entry Level Classes for the academic session 2016-17 on this Directorate's website [www.edudel.nic.in](http://www.edudel.nic.in) at the link through login ID and Password→School Plant→ School Information→ Admission Criteria (2016-17).

It is regretted to note that all the schools have not uploaded their criteria and points on the module of this Directorate.

Therefore, Managements/Heads of all the remaining Private Unaided Recognized Schools are hereby directed to upload their criteria along with points by 25/12/2015 positively. All the schools should also ensure that a flex board containing the requisite information as mentioned in this Directorate's circular dated 8/12/2015 at point No. 6 must be put at the entrance of the main gate prominently.


