**ORDER**

Whereas, M/s Ghanshyam Dass Surender Kumar Fair Price Shop Lic. No. 6668 situated at M-173, Raghuvir Nagar, New Delhi under Circle 26 (Madi Pur) was placed under suspension vide this office suspension cum show cause notice dated 20/09/2014 alleging therein that on 25.05.2014 as per direction of worthy Commissioner F&S, a team of enforcement visited the business premises of M/s Ghanshyam Dass Surender Kumar Fair Price Shop Lic. No. 6668. During the course of inspection and scrutiny of the record, the following shortcomings/variation of highly subsidized Specified Food Articles was detected by the inspecting n reported by the inspecting team:

1. The Net variation of 7.13 qtls of Wheat and 0.90 qtls of Sugar was found.

Further, after approval of Worthy Commissioner, Food & Supply Deptt. the team lodged an FIR No. 653 dated 28.08.2014 in P.S. Khayala against the licensee.

And, whereas, aggrieved by above action, the FPS holder filed an appeal cum stay application before Joint Commissioner (West) /Appellate Authority. The Jt. Commissioner (West)/ Appellate Authority after hearing the case at length set aside the suspension order dated 20.09.2014 and passed an order dated 11.12.2014 as under:

***"I hereby set aside the impugned suspension order dated 20.09.2014 in the interest of justice. However as a warning to the appellant for remaining careful in future. I order for forfeiture of entire security amount of the appellant. This order is without prejudice to the action taken by the competent court in the trial case."***

Therefore, I Vimal Kumar, Asstt. Commissioner (West), Food & Supplies Department in exercise of the powers conferred upon me under the provisions of Delhi Specified Articles
