## ORDER

Whereas, M/s Trilok Gen. Store Fair Price Shop Lic. No. 8088 situated at RZF-40 B Nihal Vihar, New Delhi under Circle 11 (Nangloi Jat) was placed under suspension vide this office order dated 23/05/2014 and Fair Price Shop Lic. No. 8088 was cancelled vide this office order dated 21/08/2014 alleging therein that on 01.05.2014 as per direction of worthy Commissioner F&S, a team of enforcement visited the business premises of M/s Trilok Gen. Store, Fair Price Shop Lic. No. 8088. During the course of inspection and scrutiny of the record, the following shortcomings/variation of highly subsidized Specified Food Articles was detected by the inspecting n reported by the inspecting team:

- 1. No books of accounts were available in the premises. The sales person asked for some time to get the records from his house. He was allowed to bring the record and the same was seized by the inspecting team from the possession of the sales person of the said FPS.
- 2. The Net variation of 0.51 Qtls of Wheat and 4.31 Qtls of Rice was found short.
- 3. There was no information as per departmental guidelines displayed outside the FPS. i.e. Licensee name and authority name, time of opening of FPS, weekly off, procedure for making complaints indicating the authority for redressal of grievances of consumers, stock as on date etc.
- 4. Samples of wheat and rice were not available in the FPS.
- 5. Complaint Register was not available/ maintained in the FPS

And whereas an FIR No. 308 dated 03.05.2014 under the Essential Commodities act, 1955 has been registered in the Police Station, P.S. Nihal Vihar, New Delhi.

And, whereas, aggrieved by above action, the FPS holder filed an appeal cum stay application before Joint Commissioner (West) the Appellate Authority under clause 6 of Delhi Specified Articles (Regulation of Distribution) order 1981 against the Cancellation

order dated 21.08.2014 of the undersigned. The Jt. Commissioner (West) the Appellate Authority passed an order dated 04.12.2014 as under:

"I am of the view that the impugned cancellation order dated 21.8.2014 passed by the respondent is unjustified and without application of mind. So the said impugned cancellation order dated 21.8.2014 is hereby set aside in the interest of justice. However, as a warning to the appellant for remaining careful in future, I order for forfeiture of entire security amount of the appellant. This order is without prejudice to the action taken by the competent court in the trial case."

Therefore, I Vimal Kumar, Asstt. Commissioner (West), Food & Supplies Department in exercise of the powers conferred upon me under the provisions of Delhi Specified Articles (Regulation of Distribution) Order, 1981 do hereby **RESTORE** the authorization/license of the **FPS 8088** in the name and style of **M/s Trilok Gen. Store** pending enquiry with immediate effect.
