## **ORDER**

No.F.3 (4)/2002/F&S/P&C/Vol.I: Whereas the Lt. Governor of the National Capital Territory of Delhi rescinded the Delhi Edible Oils-(Licensing and Control) Order, 1977, vide Order No.F.9 (1)/97-F&S (P&C)/(ii)/252 dated 9<sup>th</sup> March, 1998 and the Delhi Pulses (Licensing of Dealers) Order, 1974 vide Order No.F.3(17)/2003/F&S/Policy//206 dated the 12<sup>th</sup> July, 2004.

Whereas the Central Government vide Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs, Notification No. S.O. 2559(E) dated 30.09.2014 has issued the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Amendment) Order, 2014;

And whereas clause 1(1), 1(2) and 2 of the aforesaid Order provides:-

- 1. (1). This Order may be called the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on specified Foodstuffs (Amendment) Order, 2014.
  - (2). It shall come into force on the Ist day of October, 2014.
- 2. In the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, in clause 7, in sub-clause (1), in item (i), for the expression "30<sup>th</sup> September, 2014", the expression "30<sup>th</sup> September, 2015" shall be substituted.

Now, therefore, the Lt. Governor of National Capital Territory of Delhi, in exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the order issued by the Government of India, Ministry of Agriculture (Department of Food) Notification No.G.S.R.800 dated the 9<sup>th</sup> June, 1978, hereby orders that Order No.F.9(1)97-F&S(P&C)/(ii)/252 dated the 9<sup>th</sup> March, 1998 and Order No.F.3(17)/2003/F&S/Policy//206 dated 12<sup>th</sup> July, 2004 relating to the Delhi Edible Oils (Licensing and Control) Order, 1977 and Delhi Pulses (Licensing of Dealers) Order, 1974 respectively, shall be kept in abeyance, to the extent of the provisions of the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Amendment) Order 2014 dated 30.09.2014 for a further period up to 30<sup>th</sup> September, 2015 in respect of edible oils, edible oilseeds and pulses.
