**ORDER**

Sub: Complaints against FPS Owners regarding illegal custody of ration cards for drawal and selling of SFAs.

Hon'ble Minister, F&S has received a number of complaints from various quarters alleging that Fair Price Shop Owners in various areas have few ration cards in their custody for illegal drawal and selling of Specified Food Articles (SFAs).

Since the allegation is of serious nature, all FSOs are directed to check the allegations in their respective area and submit a 'certificate' from each of the FPS owners that none of them have any ration card in custody, failing which strict action as per law will be taken against them. The copy of the note dated 23.12.2015 of Secretary to Minister, F&S is enclosed herewith.

All ACs are accordingly directed to submit the above certificates through respective Zonal Special/Joint Commissioners to the Policy Branch by **31.01.2016 positively**.
