ORDER

Vide Cabinet Decision No. 2158 dated 11.6.2015 circulated vide F.3/3/2013/GAD/CN/dsgadiii/2655 dated 16.6.2015 the Govt. of NCT of Delhi has decided simplify the process of renewal of Excise Licenses of Hotels/Clubs/Restaurants by making it completely online. The following has been approved:

“(i) The Excise Licence for Hotels/Clubs and restaurants may be considered for renewal, without waiting for the renewal of linked licenses of MCD/Delhi Police/DOT etc. However, in case, the Health Trade Licence/Eating House Licence/DOT approval etc. of a Hotels/Clubs and restaurant is terminated by the concerned authority, on receipt of such information, the Excise Licence shall also be liable for termination. **A list of such Hotels/Clubs and restaurants whose licence(s) are renewed during each financial year in above manner shall be furnished to MCD/Delhi Police/DOT/Fire Department. However, in case of Hotels, an affidavit regarding Star Categorization shall be required to address any issue of any change therein.**

(ii) As regards DVAT and IT returns, presently required, it is submitted that the same may also be dispensed with and instead the licensee shall file an affidavit that the VAT/Income Tax registration is valid and returns filed. For DVAT a link could be given to Excise to ascertain finally filling of return or any dues as the case may be. **This affidavit may be given in a combined form along with the affidavit regarding seat covers and no change in the licensed premises and Star Categorization of Hotels (in case of Hotels), no change in number of member (in case of clubs).**

(iii) Affidavit regarding compliance of Fire Safety Measures is required if the seating capacity is below 50 seat covers and if the seating capacity is more than 50 seat covers, valid NOC from Fire Department is to be obtained by the Licensees being a mandatory requirement from Fire Department. Here also an affidavit should suffice and excise licence shall stand cancelled if the Fire department orders to close the premises/cancel their permission accorded to the licensee.”


