ORDER

This office has issued order No.F-24(1)/ETO/2015-16/ 2528-33/2731 on 15/09/2015 as under:

*"The application for Entertainment programme is required to be submitted seven clear days before the date of such Entertainment in the Entertainment Tax Department. It has been noticed that the same is not being followed properly causing problems in effective and timely disposal of the applications.*

*The Department has moved to online applications and processes to facilitate the Entertainment Industry. In order to ensure compliance of the Act and Rules as the Department facilitates online processes, the Commissioner (Excise, Entt. & Luxury Tax) under Section 46 of the Delhi Entertainments & Betting Tax Act, 1996, issues the following directions for compliance w.e.f 1<sup>st</sup> October, 2015:-*



Sl. No.	Application submission time	Application Charges
1.	Application submitted before 7 days of event.	No fees
2.	Application submitted before 5 & 6 days of the event	Rs. 5000/-
3.	Application submitted before 4 & 3 days of the event	Rs. 10,000/-
4.	Application submitted before 1 & 2 days of the event	Will Not Be Accepted

*Now therefore all the event organizers are hereby advised to file applications providing intimation regarding holding of events as per section 8 of the Delhi Entertainments & Betting Tax Act, 1996 and the rules framed there-under before seven days of the date of event as required under rule 11 of the Delhi Entertainments & Betting Tax Rules, 1997 so as to avoid any application charges. This order shall come into force with effect from 1st October, 2015."*



Now, in partial modification of above order the Commissioner (Excise, Entertainments & Luxury Tax), Government of NCT of Delhi orders following modification at S. No. 4 of the above order **with immediate effect** in order to facilitate the event organizers to apply **One or Two days** before the event:
