ORDER

This is with reference to the verification exercise conducted by the Deptt. Despite door-to-door verification of OAP, Disability & Widow Pension beneficiaries and thereafter, several ads in the newspapers informing beneficiaries to get themselves verified, there are still many whose living status is not clear. Therefore, in a Plan Review meeting, Hon'ble CM has desired that Camps may be held in every constituency to give these beneficiaries one last chance to get themselves re-verified so that their pension may be remitted.

Hence you are requested to get in touch with your area MLA to identify a suitable location for holding a re-verification camp for all three schemes, namely, OAP, Disability & Widow at the earliest. The Camp should be in an easily accessible location where the majority of beneficiaries that are to be re-verified are clustered. The location should preferably be in a building with seating facility, fans, toilet and drinking water. It should also have electricity points to run at least two computers. The computers/laptops will also need to be arranged by you.

In the absence of such a location, kindly choose a spot which can be covered with shamiana and the other above-mentioned facilities be also provided there. For this the DSWOs will be provided funds as below to organise the Camp.


The MLAs have already been provided with the data of the beneficiaries of OAP, Disability & Widow Pension, to be re-verified. You are to coordinate with the MLAs so that their volunteers go to these addresses personally and inform the beneficiaries about the Camp and to get themselves verified if they have not yet received their pension. We may also distribute leaflets through them giving the details of the Camp as well as the documents required.

The Camp shall function from 10.00-4.00 pm at the location, where 3 staff and 3 Supervisors of the area shall be deputed. The District Office shall also function as usual.

On the Camp Day, the details of the beneficiaries would be checked against the data of the Department and relevant documents collected at the venue. Later on, at the District Office, the data of the beneficiaries will be entered with necessary additions, modifications and pension, with arrears, of those reverified will be remitted on a weekly basis.

A draft letter to the MLAs requesting their help with the Camp venue and other requirements is enclosed for your reference. You are requested to send these letters to the respective MLAs at the earliest with a copy to this office also.
