A summary of the directions given by the Hon'ble Supreme Court of India in Union of India & Anr Vs National Federation of the Blind and Ors [Civil Appeal No. 9096 of 2013 (arising out of SLP (Civil) No. 7541 of 2009)] in its judgment dt: 08/10/2013 on the matter of reservation for Persons with Disabilities as well as the relevant DOPT OMs in this regard is attached for perusal. The relevant DOPT OMs can also be accessed on the web site.

The Department of Social Welfare is the Nodal Department for implementation of the Persons with Disabilities Act 1995. One of the important provisions of the Act is providing 3% reservation to Person with Disabilities in Government employment (Section 33), out of which 1% shall be reserved for PwDs suffering from blindness or low vision, hearing impairment and locomotor disability or cerebral palsy in the posts identified for each disability.

It is regretted that despite several letters from Disability Welfare Branch and meetings held at higher levels, no progress has been made in assessing the vacancy position for reserving 3% of the vacancies to persons with disabilities and identifying the posts suitable for specific category of Persons with Disability.

The Government of India as well as the Chief Commissioner and Commissioner Disability, Delhi, have been pressing hard for the relevant information. The Chief Secretary has also desired to hold a meeting in this regard on 04/09/2015.

You are therefore directed to prepare cadre wise roster for reservation to Persons with Disability as per the extant DOPT OMs. The rosters be put up on file by 17/08/2015.
