ORDER

In pursuance to Resolution No.1/2015, dated 7.4.2015, of the minutes of STA meeting, circulated vide letter No.F.10/108/AS/STA/Tpt/2013/PF/34-43 dated 9.4.2015, and in amendment to Resolution No.1/1998 of STA dated 23.7.1998, it is hereby ordered that the officers of Delhi Police of the rank of Asstt. Commissioners of Police and above shall continue to exercise the powers delegated u/s 86 (4) of MVA, in case of Heavy and Medium transport vehicles and Light Goods Vehicles being four wheelers only.

2. However, the powers delegated to the above mentioned officers of the Delhi Police are hereby limited to the rest of the vehicles categories (other than the above mentioned categories), for following violations only:-

- i. Driving without valid permit;
- ii. Driving without certificate of fitness;
- iii. Driving without Motor Vehicle License.
- iv. Drunken driving

3. Further, in pursuance to Resolution No.2/2015, dated 7.4.2015, of the minutes of STA meeting, circulated vide letter No.F.10/108/AS/STA/Tpt/2013/PF/34-43 dated 9.4.2015, and in amendment to Resolution No.1/1998 of STA dated 23.7.1998, powers to suspend the permits of vehicles under section 86 (4) of the Motor Vehicles Act 1988, are hereby also delegated to Additional District Magistrates and Executive Magistrates (Tehsildars), in addition to Dy. Commissioner and Sub-Divisional Magistrates of the Revenue Department GNCTD.


