ORDER

As a number of complaints about improper functioning of Show-rooms – workshops of Motor Vehicles Dealers are received in this office, during public hearings and through various dignitaries. In order to resolve these complaints all the MLOs / Registering Authorities are hereby instructed to:-

1. Check the motor vehicles dealers show rooms and workshops in their jurisdiction and if any unauthorized show room is found, FIR be lodged immediately at the level of MLO. All inspection reports to be preferably accompanied with photographs at site.
2. Check all workshops of heavy commercial vehicles (i.e. TATA, Ashok Leyland, Swraj Mazda, Force, Mahindra etc.) and those dealing with CNG vehicles to ensure proper functioning of Pollution Checking Centre and other facilities required as per rules. Wherever deficiencies are found, show-cause notices be issued at the level of MLOs.
3. Check whether the concerned dealers who had submitted undertaking of obtaining DPCC certificate at the time of grant of Trade Certificate, have got valid DPCC certificate or not.
4. Check whether Pollution Control Centre is installed in all the workshops (except dealers of electric vehicles and E-Rickshaws & E-Carts). No Trade certificate should be renewed for those dealers who have not installed of Pollution checking Centre and have a valid DPCC.
5. If any specific complaint against any particular dealer is received, MLO concerned should immediately inquire the same and submit his report alongwith his findings / recommendations for further course of action as per MV Act/Rules to the competent authority for a decision.
6. Whether dealers specifically commercial are having washing facilities.
