ORDER

Whereas the vehicle bearing Registration no. DL2CN-6939, is registered in name of Mr. Shammi Vaid r/o O-1, Block-O, Aruna Nagar, Majnu Ka Tilla, Delhi-110054, under the provisions of section 39 of the M V Act 1988 for personal use only;

Whereas, under provision of Rule 24 of CMVR, 1989, no person shall establish or maintain any driving school or establishment for imparting instructions for hire or reward in driving motor vehicles without a license in Form 11 granted by the licensing authority.


And whereas, Deputy Comm. (ops), Transport Department, vide letter no. F.DC/Ops/2013/584-90 dated 17/06/2015 has conveyed that the said vehicle is found operating for the purpose of imparting training to prospective drivers without having a valid authorization in Form-11, (as per information received by EO, Transport Department vide letter no EO/HQ/TPT/2015/371 dated 10/06/2015), which is not authorized and liable for suspension of registration.

And whereas, the said act is a gross misconduct under the provisions of Rule 24 of CMVR, 1989 & the provisions of Motor Vehicle Act, 1988, where the vehicle registered under private category could not be used or operate under hire & reward. Hence the motor vehicle is fails to comply with the requirements of the Act and the rules made there under.

And whereas, the violation of above said provisions invites to initiate proceedings under section 53 of M V Act, 1988 which included suspension of registration.

And whereas, a registered notice was served upon you to make representation under the provisions of section 53 the M V Act, 1988 but your reply to the show cause notice no. No.MLO(NDZ)/tpt/2015/4412 Dated:- 26-06-2015 is not satisfactory.

And therefore, I, Ajay Kumar Samal, MLO & Registering Authority empowered under rule 30 of the Delhi Motor Vehicles Rules, 1993, hereby order to **suspend the certificate of registration** of your vehicle DL2CN 6939 under the provisions of section 53 of the M V Act for the period of one month with immediate effect. You are hereby, directed to surrender the original registration certificate to this office. The period of one month will be calculated from the date of surrendering the RC in my office and until the modifications / alteration in the basic feature of the vehicle are rectified. You are further directed not to ply this vehicle during this suspension period failing which punitive action shall be taken.
