ORDER

Attention of all MLOs / Self-Registering Dealers are invited towards the enclosed Notification No.F1(2)(3)/Accts/Rev/2015-16/217 dated 16.09.2015 issued by the Special Secretary of this Department vide which the rates to be levied upon a motor vehicle described in column (1) of part B of Schedule-I has been increased by an additional amount of twenty-five percent of the existing rates or the amount, as the case may be for the private motor vehicles registered in the name of companies and firms except the motor the motor vehicles registered in the name of an individual.

Vide above said notification, it has been further provided that in case of private motor vehicles registered in the name of companies and firms and propelled by the diesel fuel, the above amount shall be calculated over and above the amount of tax levied vide notification No.F.19(52)/Tpt./Sectt./2010/180 dated 29.09.2011.

In view of above, all the Motor Licensing Officers / Registering Authorities including Self-Registering Dealers are hereby directed to keep on hold the registration of such vehicles in the names of companies and firms till further orders.

If any loss of revenue is found due to such registration without proper charging of tax as per above notified increase, all responsibility in this regard shall lie with the Registering Authority concerned.



NOTIFICATION

No.F.1(2)(3)/Accts/Rev./2015-16/ — In exercise of the powers conferred by the second proviso to sub-clause (ii) of clause (b) of sub section (1) and sub section (2) of Section 3 of the Delhi Motor Vehicles Taxation Act, 1962 (57 of 1962) and in continuation of notification no. F.19(52)/Tpt./Sectt./2010/180 dated 29th September, 2011, the Lieutenant Governor of the National Capital Territory of Delhi hereby increase, with immediate effect, the rates of tax to be levied upon a motor vehicle described in column (1) of Part B of Schedule-I by an additional amount of twenty-five per cent of the existing rates or the amount, as the case may be, for the private motor vehicles registered in the name of companies and firms except the motor vehicles registered in the name of an individual.

It is further provided that in case of private motor vehicles registered in the name of companies and firms and propelled by the diesel fuel, the above amount shall be calculated over and above the amount of tax levied vide notification No.F.19(52)/Tpt./Sectt./2010/180 dated 29th September, 2011.

सं.फा. 1(2)(3)/एकाउंट्स/रैवेन्यू/2015-16/ - दिल्ली मोटर वाहन कराधान अधिनियम, 1962 (1962 का 57) की धारा 3 की उपधारा (1) के खंड (ख) के उपखंड (ii) के द्वितीय परन्तुक तथा उपधारा (2) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए तथा अधिसूचना सं० फा० 19(52)/परि०/सचि०/2010/180 दिनांक 29 सितम्बर, 2011 की निरंतरता में राष्ट्रीय राजधानी क्षेत्र दिल्ली के उपराज्यपाल, व्यक्तिगत नाम से पंजीकृत मोटर वाहनों के अलावा कंपनियों तथा फर्मों के नाम से पंजीकृत निजी मोटर वाहनों के लिए अनुसूची-1 के कालम (1) के भाग ख में वर्णित मोटर वाहनों पर वसूलनीय कर की दरों में तत्काल प्रभाव से बढ़ोतरी करते हैं जो वर्तमान दरों या राशि, जैसी भी स्थिति हो, का पच्चीस प्रतिशत की अतिरिक्त राशि होगा।

यह भी आगे प्रदान किया जाता है कि डीजल ईंधन से चलित कंपनियों तथा फर्मों के नाम से पंजीकृत निजी मोटर वाहनों के मामले में यह उपरोक्त राशि 29 सितम्बर, 2011 की अधिसूचना सं० फा० 19(52)/परि०/सचि०/2010/180 के अनुसार वसूलनीय कर की राशि के ऊपर अतिरिक्त परिकलित होगी।
