**ORDER**

Attention of all the Registering Authorities / MLOs are hereby invited towards the requirement of having a Pollution Checking Unit / washing facilities by a dealer. In recent months, a number of proposals for issue of fresh Trade Certificates / Renewal of Trade Certificates had been received in the Operation Branch from the Registering Authorities / Motor Licensing Officers with their recommendations for granting approval, in which the dealer has (1) applied with DPCC for having washing facilities and submitted a copy of the same and / or (2) applied for installation of Pollution Checking Centre and submitted a copy of the same and accordingly, (3) or filed an undertaking that these facilities shall be ensured by the dealer in a time bound manner. The competent authority considering the constraints and taking a lenient view, had granted approval for grant of Trade Certificates subject to having these facilities in a time-bound manner. However, no feedback has been received from the MLOs whether all such dealers have installed or established the above facilities in their workshops or not so far.

In view of above, all the Registering Authorities / MLOs should ensure that all the dealers under their jurisdiction (Except dealers of Electric vehicles, E-Rickshaws and E-Carts) are having washing facilities with valid DPCC & functional Pollution Control Unit in their workshop and also to ensure that whether all such dealers which have been granted Trade Certificates in recent months subject to installation of Pollution Checking Unit/Washing facilities in their workshops, had got the same installed or not as per undertaking submitted / time mentioned in the proposal.

A factual status report in this regard shall be furnished to the MLO (Operations) within a week without fail.
